WATER'S IMPACT ON NEOGEN

Neogen's customers also face challenges with long term municipal water availability as droughts create stress on these suppliers, as well as municipal water being regulated for human consumption. That means municipal water can be scarce and may not be the best water quality parameters for food production, creating economic hardships on food producers. Scarcity of water supplies as a whole is another challenge their customers face, so water usage reduction, as well as reuse are new opportunities Neogen aids customers in taking advantage of.

APPROACH TO WATER

Since Neogen manufactures multiple water treatment chemistries, they take a customized approach to water, meaning they fit the treatment to the customer and their expectations, rather than trying to fit the customer into a single, "black-box on the wall" solution.

Additionally, Neogen's customers are rewarded based on their performance compared to their peers. Many have won "Farm of the Year," "Performer of the Year, etc. However, the real reward is a larger performance-based check when they market their products (poultry, pork, beef, and milk).
